## KNOW YOUR RIGHTS

This workshop empowers immigrants and allies with essential information about legal rights, covering protections at home, work, and in vehicles. Gain insights and guidance on interactions with law enforcement. Participants will also learn about the new immigration policies currently in effect.

## FAMILY PREPAREDNESS PLANNING

This workshop provides crucial information for individuals in the need of creating strategies for immigration-related emergencies. Participants will learn how to develop a family plan to stay safe and informed during times of uncertainty.

Additionally, the workshop will provide an overview of new policy implementations.

### LEGAL EMPOWERMENT AND GRASSROOTS PARTICIPATION

This workshop explores the legal empowerment movement led by grassroots communities to democratize the law and redistribute legal power to those directly impacted by injustice. Participants will discover strategies beyond traditional legal avenues, gaining insights into creative solutions for addressing legal challenges. Workshop hosts offer tangible support to participants interested in developing their own programming and can refer participants to existing LEP efforts in Orange County.

## EMPOWERING WORKERS IN CALIFORNIA

The presentation will focus on empowering workers with knowledge of their rights and resources across various workplace scenarios. It covers topics such as workers' compensation, filing complaints with state agencies, protections against retaliation, and avenues for accessing unemployment, disability, and paid family leave benefits through the California Employment Development Department (EDD).

We'll break down how laws are made, what executive orders and court decisions mean, and how to stay informed about immigration policy changes..
